&2 Objectives

2. The objective of the competition is to review the photographic creations of photographers who use traditional, manual photographic methods in present day photography and to present their most interesting achievements.

&3 Rules of participation

- 3. The competition may be entered by individuals aged 18 and over and have full legal capacity as well as by minors of at least 13 year of age with the written permission of their legal guardians.
- 4. Submitting work for the Competition signifies the wish to enter the Competition and is tantamount to accepting these Rules of Entry. In the case of minors a submission must be accompanied by a written statement signed by their legal guardian. This statement is an annex to the Rules of Entry.
- 5. The competition is open to all photographers. A Polish entry form is available from the organizer's website www.szlachetnafotografia.com. An English entry form is available from the organizer's website www.aternativephotographicsupplies.com. All submissions must be sent to the following address:

- 6. The images submitted may be taken at any time or location
- 7. Each author may submit 5 works in each category. Sets, consisting of no more than 6 images in each, are treated as a single work. One author may only make one submission. The jury reserves the right to re-edit the sets, in particular to choose single images for the purpose of the exhibition. The jury may also award single images from particular sets.
- 8. The sets of images submitted for the competition must be arranged in the order of presentation and this information along with the image orientation must be indicated on the reverse of each image.
- 9. The minimum size of the images submitted is 13x18cm (size of the image itself). The maximum size of the images submitted is 50x70cm. The maximum size of the paper the image is printed on is 70x100cm. Prints submitted for the competition must be unframed and should not be presented in the form of a passe-partout but as a loose sheet.
- 10. The prints may be entered in two categories:

Pinhole photography

In this category only photographs taken by means of camera obscura are admissible.

Alternative photography

In this category only handmade prints made by means of manual photographic processes such as: ambrotype, calotype, platinotype, palladotype, cyanotype, Vandyke brownprint, aurotype, orotone, saltprint (talbotypie), albumen print, gum bichromate, woodburytype, argentotype, argyrotype, cuprotype, oilprint, bromoil, carbon transfer, carbro, caseinotype, liquid emulsion, transfers and lifts including polaroid transfer and not limited to the above. Mixed techniques and the photographer's own techniques are also admissible. The prints may be made both from traditional film negative and from negatives printed from digital files.

Prints using factory made silver gelatine papers as well as any form of digital prints and photographic lab made prints are not admissible in this category.

- 12. Each print submitted for the competition must have the following information clearly inscribed at the back:
 - The author's pseudonym
 - The technique used
 - Title (optional)
 - Information about image orientation
 - Image order in the set (in case of sets)
 - Category to which the image is submitted
 - Image number identical with the one given in the entry form.

The filled entry form in a sealed envelope sighed with the author's pseudonym must be included in the submission along with confirmation of payment of the entry fee. The information included in the entry form will be available to the organizers only and will not be disclosed.

Each entry must be accompanied by a CD or DVD containing the digitalized images from the submission. Each file should be 3000 pixels along the longer edge.

Works which do not meet the above criteria will not be accepted for the competition.

&4 Assessment and prizes

- 13. The competition will be juried by Dr hab. Witold Jurkiewicz, Adam Mazur, Małgorzata Taraszkiewicz-Zwolicka and Radosław Brzozowski
- 14. The deliberations of the jury are open to anyone interested in them.
- 15. The Jury will assess photographs with respect to the technique, originality and creativity as well as the cathegory they are submited in
- 16. The photographs ans submissions that do not meet the criteria stipulated in these rules of entry will not be submitted to the Jury.
- 17. Minutes of the Jury will be signed by all Jurors
- 18. The verdict of the jury is final.
- 19. The following prizes will be awarded:
 - a. Grand Prix Grand prix will be awarded to the photograph with the highest artistic and technical value presenting the original vision of the author. It will be accompanied by a financial award of 3000 zloties
 - b. Two equal first prizes, one in each category accompanied by a financial award of 1500zł
 - c. Honourable mentions accompanied by participation in the exhibition at the National Museum in Gdansk and publication in the exhibition catalogue.
- 20. The jury reserves the right to amend the division of prizes, in particular the right not to award each of them. The organizers, sponsors and partners may not influence the decisions of the jury in any way other than through their representative in the jury.
- 21. The tax for the prizes is paid by the participant awarded.
- 22. The prizes may not be exchanged to a financial or material equivalent or transferred to other persons.
- 23. The prizes will be paid in Polish currency by transfer to a bank account provided by the participant. A different method can also be used, subject to agreement with the Winner. The prizes will be paid within 14 days of 19 March 2020, the opening of the exhibition.
- 24. The organizers reserve the right to free reproduction and publication of the submitted images in the catalogue as well as in the Press, TV and Internet for purposes connected with the promotion of the *Then & Now* competition as well as to keep them for archival purposes with full observance of the author's copyright. All the prints remain the sole property of their authors and will be returned to them after the jury or, in the case of prints accepted for the exhibition, after the exhibitions.

25. Publishing the results of the competition at www.szlachetnafotografia.com and at www.szlachetnafotografia.com will be considered as informing the participants about the results.

&5 Exhibition and catalogue

- 26. Photographs accepted for the exhibition will be published in the exhibition catalogue
- 27. The exhibition will be shown in the Gdansk Gallery of Photography, part of the National Museum in Gdansk from 19 March 2020 until 24 May 2020. All authors of the photographs accepted for the exhibition will receive a free copy of the catalogue.
- 28. The Organizers reserve the right to present the exhibition in other spaces than the above at any date of their choice prior to 5 May 2021.

&6 Competition calendar

- 30. Announcing the competition: 29 November 2019
- 31. Deadline for submitting entries: 20 January 2020 the date of the postal stamp is decisive.
- 32. Jury, awarding prizes and unofficial announcement of results: 6 February 2020.
- 33. Official announcement of the competition results: 10 February 2020.
- 34. Opening of the exhibition: 19 March 2020.
- 35. Prints not accepted for the exhibition may be reclaimed between 1 March and 30 May 2020 at the organizer's address. All the prints whose authors paid for their return will be shipped to the authors during the same period. After 30 May 2030 all the prints which have not been reclaimed by the authors or whose return shippment has not been paid for will be destroyed.
- 36. All the prints accepted for the exhibition will be returned in May 2021 under the same conditions.

&7 Reclaiming competition prints

- 37. Authors may reclaim their work in person at the organizer's premises at the time given in points 30 and 31 above.
- 38. The works may also be shipped to the authors at their own expense. The cost of shipment depends on the author's address and will be as follows:
 - Shipment to Poland 25 zloties
 - Shipment to the European Union and Schengen 15 euros
 - Shipment to other countries 20 euros.

&8 Personal data protection

- 39. The following personal data will be collected by the Organizer:
 - 1. Participants:
 - a. Name and surname
 - b. Date of birth
 - c. Address
 - d. Telephone number
 - e. Email address
 - 2. Participants represented by their legal guardians/representatives
 - a. Name and surname of both the Participant and legal guardian/representative
 - b. Date of birth of both the Participant and legal guardian/representative
 - c. Address of the legal guardian/representative
 - d. Telephone number of the legal guardian/representative or of the Participant
 - e. Email address of the legal guardian/representative or Participant
 - 3. Winners
 - a. All the above
 - b. Bank account number used for transferring the prize.
- 40. The data controller during the Competition is Radosław Brzozowski TSF Trójmiejskie Studio Fotografii located in Gdynia at 34 Wierzbowa St. The data will be processed in accordance Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation). The administrator of the personal data has selected the Data Protection Officer responsible for ensuring the correct handling of the personal data who can be contacted at brzozowski@tsf.edu.pl.

- **41.** The personal data of Participants and their legal guardians/representatives will be processed by the Organizer for the purpose of conducting the Competition and publication of its results in accordance with the Rules of Participation, in particular for communication with winners and for the payment of prizes.
- **42.** The submission of personal data is voluntary, however, should a Participant or their legal guardian/representative refuse to submit such data or refuse permission to process it for the purpose of conducting the competition, their submission will not be accepted for the competition and will be destroyed.
- **43.** The Participant authorizes the Organizer to use his name and surname for the purpose of announcing the competition results including publication in mass media and social media as well as on the websites of the Organizer.
- **44.** The personal data of Participants and their legal guardians/representatives will not be revealed to third parties with the exception of situations where it is required by law.
- **45.** The personal data of Participants and their legal guardians/representatives will be deleted within a month from the moment when its processing for the purpose of organizing the competition ends with the exception of the names and surnames of Winners.
- **46.** The Organizer will implement appropriate security measures appropriate to the risk and type of personal data collected in particular with respect to the risk of:
 - a. Accidental or illegal destruction of the data
 - **b.** Loss, modification or unauhorised publication of data
 - c. Unauthorized access to the personal data sumbitted stored and processed.

&9 Author's copyright

- 47. The participant declares that the work submitted for the Competition is his or her own individual work and is free from rights and claims by third parties including copyright and related. The participant is responsible to the Organizer in this respect and indemnifies him from all claims that third parties may have.
- 48. By submitting the prints for the competition, the participant grants an unpaid, non exclusive right, unlimited by time or location, to use the work (license with respect to copyright and related rights) in the following fields:
 - a) Multiplying and recording (including placing in the computer memory) by any means.
 - b) Making the work available to the public for the purpose of promoting the competition in such a way that anyone can access it at time and place of their choice.
- 38. The participant states that he grants the right to use his or her likeness in connection with the competition and in the case when the image show other people, the participant states that he or she has the permission of all the people visible in the photograph to use their likeness for the purposes of the competition

&10 Final statements

- 39. The participant is fully and solely responsible for any breach of the rights of third parties which may have been incurred by submitting the photograph for the competition.
- 40. Employees of the organizers, members of their families and employees of the National Museum in Gdansk may not take part in the competition.
- 41. By entering the competition the participant fully accepts these rules of participation.
- 42. The competition conducted in accordance with these rules is not a lottery or bet whose result depends on accident in the understanding of Article 2 of the regulation from November 19th 2009 regarding gambling (Journal of Laws of the Republic of Poland No.2016.471)
