

Visiting Rules
Department of Modern Art
National Museum in Gdańsk
during the COVID-19 pandemic

1. Visiting the exhibitions at the National Museum in Gdańsk's Department of Modern Art takes place at the times and dates provided on the National Museum in Gdańsk's website and on the information boards at the entrance to the Dept. of Modern Art.
2. The Dept. of Modern Art can accommodate no more than 40 visitors at a time, with 20 visitors on each floor.
3. Visitors are obliged to:
 - a) cover their mouth and nose at the Dept. of Modern Art,
 - b) maintain a distance of minimum 2 metres from the other visitors and the staff of the Dept. of Modern Art,
 - c) disinfect their hands before entering the exhibition halls and in the rest rooms.
4. The Museum may be visited individually or in groups of maximum 5 people, while maintaining the required distance of 2 metres between visitors.
5. Detailed information about visiting the permanent and temporary exhibitions, areas that are temporarily unavailable and ticket prices is posted at the box office and on the National Museum in Gdańsk website.
6. A ticket to the National Museum in Gdańsk entitles its bearer to visit the museum exhibitions.
7. Documents entitling to discount tickets should be shown before their purchase.
8. The exhibitions can be visited only with a valid Museum ticket or a document entitling to visit the Museum free of charge.
9. The cloakrooms at the Dept. of Modern Art are closed. Therefore, visitors cannot leave their clothes there. A place to leave their umbrellas, luggage and/or backpacks will be made available to the visitors. The Museum shall not be responsible for these objects.
10. The Museum shall not be responsible for valuable items, documents and money left in the cloakroom or on the premises of the Dept. of Modern Art.
11. Visitors at the Dept. of Modern Art should follow the instructions of the National Museum in Gdańsk's staff and the security staff.
12. At the Dept. of Modern Art it is prohibited to:
 - a) touch the exhibits and interior décor, step into roped-off areas, sit on the furniture, run and slide on the floors;
 - b) walk in with or carry in animals (except for guide dogs for people with disabilities);
 - c) smoke or use any open fire;
 - d) be under the influence of alcohol and/or other intoxicating substances;
 - e) carry in and eat/drink food and/or beverages;
 - f) carry in guns and/or sharp objects;
 - g) enter staff rooms outside of the exhibitions;
 - h) take photographs or record videos with a stand, flash or other artificial light;
 - i) talk loudly and/or use mobile phones in a way that would disturb other visitors nearby.
13. People under the influence of alcohol and/or drugs or who act in a way that threatens the safety of the collection and/or people, who disturb other visitors, violate general standards of good behaviour in public spaces and those violating the prohibitions provided in point 12 above, may be asked to leave the Dept. of Modern Art; in special cases they may be subject to legal action.
14. The visitor shall be liable for any damages they cause or caused by a person under their care, in accordance with the law.
15. The parents or minders of minors are responsible for their actions.
16. The final entrance to the Dept. of Modern Art can take place no later than 30 minutes before its closing.
17. Visitors are obliged to leave the Dept. of Modern Art by its closing time. The closing time of Dept. of Modern Art is the moment by which the visitors should leave the Dept. of Modern Art, taking into account the time necessary to collect their belongings from their designated place of storage.
18. Individual and group guided tours are suspended until further notice.
19. Museum lessons, workshops, conferences, lectures, concerts and previews are suspended until

further notice.
